

APPOINTED DIRECTOR CONFIRMATION – Agenda item 5

The Board has three Appointed Directors, with the Nominations and Selection Committee undertaking recruitment processes to identify appropriate non-member Directors for appointment to the Board under clause 33.2 and 33.5 of the Constitution.

Clive Addison was appointed in 2020 and has completed a 12-month and 2-year appointment, and his time on the Board comes up for renewal this year. Angus Armour was appointed to the Board in July 2022 on an initial term through to the 2023 AGM. The Board recently re-appointed Clive on a 3-year term and Angus on a 2-year term to match the standard 3-year rotation of all directors on the Board.

The Corporations Act requires the confirmation of Board appointed Directors at the AGM.

MEMBER DIRECTOR ELECTION - Agenda item 6

The College Board is made up of six elected Member Directors and three non-member Appointed Directors. Directors are usually elected or appointed on 3-year terms, which are staggered, meaning each year two member Directors positions are up for election.

The Board, as detailed in the Constitution, has assigned the selection and appointment of Directors to the independent Nominations and Selection Committee. The Nominations and Selection Committee ensures the College has a balanced and appropriately skilled board of directors to deliver a strong and successful College for members.

The Nominations and Selection Committee comprises:

- Mark McCoy (chair) experienced company director and governance expert
- Peter Lang College Fellow, paramedic educator, former College director with over 10 years' service on the board
- Namoi Dougall lawyer, experienced director, and senior executive
- Liz Schenke human resources expert

The Nominations and Selection Committee has identified the ideal mix of skills required on the College board. This is detailed in the College's skills matrix with identified skills required of the directors, e.g., strategy, policy development, risk, governance etc. The skills matrix is reviewed each year and highlights the skills required of directors individually and collectively for successful leadership of the College.

Under the College Constitution, all director nominations go through a consistent review process undertaken by the Nominations and Selection Committee to ensure they meet the skills requirements of the board.

There are two (2) Member Director roles becoming vacant at this annual general meeting, with Ryan Lovett and Bill Lord standing for re-election. The Nominations and Selection Committee have undertaken their role in accordance with the Constitution and have recommended Ryan and Bill to the members for re-election.

With two Members standing for two Director positions, members will vote to elect Ryan and Bill for 3-year terms.
