Description

This project is being undertaken as part of an area of interest of the researchers through the University of Southern Queensland.

The purpose of this project is to examine the attitudes and experiences of Australasian paramedics engaging in continuing professional development activities during the global pandemic (Covid-19). The literature pertaining to allied health proposes many influences on continuing professional development, which includes both attitudes and engagement. The impact of Covid-19 extends into the realm of continuing professional development by virtue of lockdowns and social distancing. Conferences, seminars, workshops and other face-to-face continuing professional development activities have been modified to online/virtual offering as a means to facilitate mandatory training, maintenance of professional/regulatory continuing professional development obligations and life-long learning desires. By investigating and comparing paramedic attitudes and experiences with continuing professional development before and after the global pandemic, we can construct a deeper understanding of paramedic engagement with continuing professional development.

Participation

Your participation will involve completion of a online questionnaire (Likert scale with some free-text options) that will take approximately 10-20 minutes of your time (depending on the length of any free-text responses that you would like to make).

Questions will include:

- Have the types of CPD activities that you would usually choose to do changed since 2020? (i.e. no longer attend face-to-face activities due to lockdowns/social distancing/etc) Answer choice: Yes/No/Unsure
- Is it easier for you to maintain your CPD now that the majority of events are held in a virtual space? Answer choice: Yes/No/Unsure
- Some type of free-text answer question about ways that they find time to engage in CPD.

Your participation in this project is entirely voluntary. If you do not wish to take part, you are not obliged to. You will be unable to withdraw data collected about yourself after the data has been analysed.

If you do wish to withdraw from this project, please contact the Research Team (contact details at the top of this form).

Your decision whether you take part, do not take part, or take part and then withdraw, will in no way impact your current or future relationship with the University of Southern Queensland.

Expected benefits

It is expected that this project will not directly benefit you. However; it may benefit the paramedic profession.

Risks

Participants are asked to complete a survey which is expected to take approximately 20 minutes to complete. As paramedics are required to complete 30 hours of CPD as part of their professional registration, this study poses no greater risks than day-to-day living activities associated with being a paramedic. However, the researchers acknowledge that some participants may be answering this survey whilst in lockdown/quarantine and could experience some level of psychological discomfort.

As the content relates to CPD in paramedicine and it is not expected that the content will elicit adverse emotions from participants.
