SESSION OVERVIEWS

Derek Collings-Hughes

Unlocking the code- professional code of conduct

Paramedicine is a newly regulated profession in Australia and with the introduction of regulation in 2018 came increased professional responsibilities – including the introduction of a professional code of conduct. We interviewed paramedics about their use and understanding of the paramedicine professional code of conduct. Through thematic analysis, this study explores the role that paramedics believe the code has in ethical and professional decision-making, the new responsibilities the code introduced as part of being a registered professional and how paramedics used the code to navigate these new responsibilities.

Informed and implied consent

Informed consent is integral to the right to information in the Australian charter of healthcare rights, and recognised in professional codes of conduct. Ensuring informed consent is properly obtained is a legal, ethical and professional requirement on the part of ALL treating health professionals and supports person-centred care. This session aims to discuss the importance of informed consent and how to achieve this in the out of hospital environment. It will also discuss the complexities of implied consent, capacity and situations where consent is not available.

The panel discussion will aim to discuss cases and complexities of consent in the out of hospital environment.

She provides an overview of the system that she has developed which is an holistic approach to acknowledging grief and healing in order reclaim aboriginal prosperity and to lessen the impacts of intergenerational aboriginal disadvantage.

Rosemary Wanganeen

Rosemary is an awarding winning proud South Australian Aboriginal woman with ancestral links to Kaurna of the Adelaide Plains and Wirungu from the West Coast of SA. 29-yrs ago Rosemary became the sole operator and owner of the Sacred Site Within Healing and in going from strength to strength, in 2021 she founded the Healing Centre for Griefology. Between 1987-1992 she became what she refers to, an intuitive researcher whereby her research question was to investigate 'not what happed when 1788 arrive' but 'why did it happened and so violently' without shaming or blaming. In so doing, she developed the Seven Phases to Integrating Loss and Grief framework which she soon realized was a missing link to dismantling Aboriginal disadvantage to re-build Aboriginal prosperity which afforded her the role as a Griefologist. Her definition of Griefology is it's the study of the human relationship between Aboriginal ancestral major losses and their suppressed unresolved grief that has compounded and complicated their contemporary Aboriginal descendants' losses and suppressed unresolved grief, guaranteeing Aboriginal disadvantage, inter-generationally! However, understanding this relationship, Griefology is a holistic system that will reclaim grieving processes that will restore prosperity which is the right of all human beings. As a result of her peer reviewed and published Seven Phases framework, and her industry experience of 29-years she was accepted into the Master of Philosophy at University of Adelaide.

Brendan Shannon

Brendan is a senior lecturer within the department of paramedicine and a registered Paramedic. Brendan is enrolled as a PhD candidate with his thesis investigating alternative care pathways by evaluating the impact of a hospital based community care program and the evaluation of the introduction of community paramedicine programs across the globe. Brendan has a keen research interest in alternative care pathways, non-transport, referral services, palliative care and community paramedicine.
