Paramedicine: Draft Clinical Practice Framework for Australasia

Why are we consulting?

The Australasian College of Paramedicine (the College) is inviting feedback on the Paramedicine: Draft Clinical Practice Framework for Australasia (the Framework). Feedback collected through the consultation process will be used to support the College in defining the clinical practice opportunities for paramedics in the future. This work will flow into a complete career framework for paramedicine that covers clinical practice, education, research, and leadership and management, and these will be addressed in separate consultations.

Providing feedback

The College has opened this consultation to gather wider feedback on the clinical practice levels the profession anticipates in future years. This framework specifically seeks to capture the most beneficial future structure for the clinical arm of the profession. The College will review all feedback received and progress necessary recommendations.

Overview/Background

With the advent of paramedic registration in Australia and Aotearoa New Zealand and the COVID-19 pandemic, there have been growing opportunities to utilise paramedics in other areas of the health system.

It's important that the profession comes together to consider future opportunities for paramedics and chart the future direction of the profession in the next decade. The knowledge, education and

capabilities of paramedics provide ample scope for broadening paramedic practice and capitalising on the many opportunities that exist for the profession to continue to grow; however, challenges and barriers to paramedics realising their full potential within the health system remain.

In 2014 in the UK, a <u>Paramedic Career Framework</u> was developed and is now in its fourth edition. This framework has played a key role in clarifying the career opportunities available to UK paramedics across the health system and helped define - for paramedics and stakeholders - the roles paramedics are able to undertake.

It's an opportune time to establish a career framework for paramedicine in Australasia. Up to now, career pathways for paramedics have been largely defined – and limited – by their role in emergency services; however, the emerging opportunities for paramedics to meet broader needs within the health system requires the profession as a whole to come together to determine a professional framework that captures the full breadth of paramedic practice and acknowledges the many contributions paramedics are making, and will continue to make, across the health sector in many different capacities.

Discussion: Draft Clinical Practice Framework for Australasia

From June to September 2022, the College, in consultation with an advisory group of paramedics, reviewed the UK Paramedic Career Framework and began collating a clinical practice framework for paramedics. This saw a review of dozens of resources from Australia, Aotearoa New Zealand, the UK and other countries on qualification levels, capabilities, and practice standards for entry-level clinicians through to advanced and consultant-level practitioners.

The UK framework is highly regarded and, in many ways, matches both the practice context and educational framework in Australasia. With Australasia already having matching levels at Level 1- Paramedic and Level 2- Specialist Paramedic, this offers an appropriate starting point for the draft Clinical Practice Framework for paramedicine in the region.

UK Clinical Practice Career Framework

The Framework utilises a four-level model, with the view to developing a similar model for education, research, and leadership and management. The framework was discussed during a representative

forum at the Australasian College of Paramedicine International Conference 2022 in September and with other stakeholders in October. General support for the four-level model was evident, while further refinement was required for the definitions. The current iteration has incorporated the feedback received in 2022 and is ready for wider consideration and discussion.

As with all frameworks, there are always exceptions, such as someone transferring from another health profession who already has a health degree and may take less time to progress or someone transitioning into paramedicine via a postgraduate degree. The Framework is a structure to support paramedicine's development and clarify career opportunities and requirements; its aim is not to cover every possibility and individual circumstance.

Once the clinical practice framework is completed, work will begin on incorporating the other practice domains of education, research, and leadership and management into the framework.

The College is investing to undertake the <u>Paramedicine Workforce Research</u> over the next three years, and this will further inform future iterations of the Australasian Paramedicine Career Framework.

<u>A note about paramedic practitioners</u>: There has been a recent announcement in Victoria about the introduction of paramedic practitioners. The College sees the roles announced as being at Level 3 – Senior Specialist Paramedic. Employers will determine the role titles they use for their specific context,

but we envision the profession determining the levels, qualifications, and broad capabilities that will help inform employers.

In relation to the name 'paramedic practitioner', the College is currently neutral on this term. We understand some in the profession support this role title while others do not. The main concern the College has is avoiding potential confusion among stakeholders and the community in drawing similarities with nurse practitioners - which is a level of practice recognised by registering bodies in Australia and Aotearoa New Zealand. The College has used a tiered level structure that follows the medical model, with specialist, senior specialist and consultant levels, rather than a nursing model in which a nurse practitioner is considered the top tier.
